### **Updates:**

Academic Programs

- BS Forensic Science- endorsed at January 2015 CADD and approved by VPAA.
   It will now move to the consent agenda for the BOT.
- <u>Modern Languages and Intercultural Communication Madrid</u> updates will be reviewed at February Faculty Subcommittee meeting.
- <u>Chinese Minor</u> awaiting further revisions of the business curricular plan and assessment. Will be reviewed at February Faculty Subcommittee meeting.

### Academic Policy Updates

Academic Definitions- Asked for any additional revisions over and above our December 2014 review. Two queries:

- 1. Has this document been vetted across campus yes, it was formerly adopted by UAAC in April 2013 after extensive review and CADD presentations x 2 over the past 4 years.
- 2. Should we define the term diploma? This would provide consistency for how we use diplomas at SLU. I will inquire with the Registrar.

## <u>New Academic Programs – No new majors, minors or certificates</u> <u>Informational updates: Global Gateway Program - Katie Donnelly, JD Bowen, and Michael Rozbicki</u>

Points of interest in consideration of this proposal were reviewed per request:

- Co-curricular project, aspire to supplement students undergraduate studies with heightened degree of global awareness.
- Practical employment of graduates this opportunity would increase marketability through increased multicultural awareness.
- Academically intercultural awareness; produce new knowledge and new teaching strategies.
- Ideological planned around SLU's mission and University undergraduate learning outcomes.

- Combination of academic, co-curricular, and service opportunities for all students in all disciplines.
- Will tie nicely into the undergraduate learning outcomes and may be an opportunity to assess this co-curricular activity.
- This will be noted on the transcript in the comment box.
- Competitive application GPA, looking for a cross-section of students across campus.
- Pilot Fall 2015 what is the limit on the pilot and are there limits of how many students per academic discipline?
- Can service hours be connected to service learning in courses yes and the
  faculty would work with faculty in these courses. Generally looking for courses
  including at least one of the following: global, international or intercultural.
- Required grade in the courses in the curriculum –students need to complete the course successfully, so at least P.
- When will a student begin the program? Ideal is as freshman so there is time to incorporate all activities into SLU experience. However, some students have already taken courses that will work and they would receive credit in the program.
- Opportunities for collaboration with the Center for Community Engagement
- It would be helpful if courses that would count toward the program on campus could be identified for student/advisor planning purposes.
- Study abroad doesn't count directly as it is an experience, but can be included in the synthesis of the program.

### **Student Success Center Syllabi Statement**

Points of interest:

- The Student Success Center (SSC) provided an announcement for a new syllabil statement inclusive of statements for SSC, Disability Services and University Writing Services (UWS). Discussed all updates, recommendation for faculty and staff is to use this common language on your syllabus. This can also be located on the CTTL website.
- Dr. Dorsey has received a number of inquiries over the past year with regard to whether or not SLU has a common suggested syllabus to guide faculty and staff when developing syllabi. At this time SLU does not have a common syllabus guide. Please notify Dr. Dorsey if your academic unit is interested.
